

# LAST WILL & TESTAMENT

## 1. Revocation

I revoke all earlier Wills.

## 2. Appointment of Executors

- a** I appoint **Insert Name** to be my executor and trustee of this my Will but if **she/he** is unable or unwilling to act or if **she/he** dies before proving my Will the following provision shall apply instead.
- b** I appoint **Insert Name** to be my executor and trustee of this my Will.
- c** The expression "my Trustees" means my personal representatives and the trustees of this Will and of any trust that might arise under it.

## 3. Appointment of Guardians

In the event my said **wife/husband** predeceases me I appoint **Insert Name** to be the guardian of any infant child of mine.

## 4. Definition of My Estate

In my Will where the context so admits "my Estate" shall mean

- a** All my property of every kind wherever situate.
- b** All my property of every kind wherever situate over which I have a general power of appointment.
- c** The money investments and property from time to time representing all such property.

## 5. Administration of My Estate

My Trustees shall hold my Estate upon trust to retain postpone or sell it and will:-

- a** Pay any debts funeral and testamentary expenses.
- b** Deal with the remainder ("my Residuary Estate") as I now direct.

## 6. Gift of Residue

I give my Residuary Estate to my children PROVIDED that they survive me by 30 days and attain or shall have attained the age of 18 years and if more than one in equal shares absolutely **but if this gift fails the following provision shall apply instead.**

- a** I give my Residuary Estate to **INSERT NAME(S)** and if more than one in equal shares absolutely. **(a can be deleted if not required along with the wording "but if this gift fails the following provision shall apply instead")**

**7. Funeral Wishes**

My wish is for my body to be cremated/buried add anything else you wish

**8. Standard Provisions**

The Standard Provisions of the Society of Trust and Estate Practitioners (1<sup>st</sup> Edition) shall apply with the deletion of paragraph 5. Section 11 Trusts of Land and Appointment of Trustees Act 1996 (consultation with beneficiaries) shall not apply.
